STUDENT CHAPTER SCHOLARSHIPS

Scholarships are available for award to members of American Society of Civil Engineers (ASCE) Student Chapters located in the State of New Jersey and members of out of State ASCE Student Chapters having their legal home address in the State of New Jersey. The Board of Directors of the New Jersey Section ASCE established these awards in 1987.

I. ELIGIBILITY:

- A) Any third year undergraduate of a four year BSCE program, or any fourth year undergraduate of a five year BSCE program who is a member of an ASCE Student Chapter may apply for these scholarships without restriction as to academic class standing or marital status, subject to the requirement that the applicant must be a member in good standing at the time of application and award.
- B) The scholarships shall be awarded only to a student who will utilize the funds to continue with undergraduate education in Civil Engineering.
- C) Previous winners of these scholarships are not eligible for this award.
- D) No more than three (3) students from any one student chapter may apply for the scholarship awards each year.

II. APPLICATION: (see enclosed copy)

Original applications must be submitted in duplicate (original plus one (1) copy) to the ASCE Student Chapter Faculty Advisor. The applications must include:

- 1) Proof of Student Chapter Membership;
- 2) A statement by the applicant of the reasons believed to justify the award;
- 3) The applicant's plans for continuing his/her education and a statement outlining how the applicant will finance his/her education if an award is granted;
- 4) Records of academic performance and standing (at a minimum, a copy of the applicant's transcript – may be an unofficial copy);
- 5) Statement of appraisal of the applicant in terms of potential for growth, character, leadership capacity and interests from the Student Chapter Faculty Advisor and at least two other members of the faculty.

The completed application must be forwarded by the Faculty Advisor to the New Jersey Section Scholarship Committee postmarked no later than **April 4, 2015** to the following address:

III. SELECTION:

- A) Up to two applicants may be selected each year to receive an award from the New Jersey Section.
- B) Selection will be made by the Awards Committee of the New Jersey Section ASCE. No faculty or New Jersey ASCE Practitioner Advisor shall serve on this committee.
- C) The Central Jersey Branch ASCE is also offering a \$2000 scholarship. Students submitting the New Jersey Section scholarship application will automatically receive consideration for the Branch award.

IV. AWARDS:

- A) The successful applicant(s) will be notified of their selection by the Scholarship Committee Chair of the New Jersey Section, ASCE, on or about May 1st following submittal of the application.
- B) The sum of each scholarship to be awarded for this academic year will be \$2,000.
- C) All awardees must provide a Social Security number if requested.
- D) The scholarship award winners will be invited to the Annual Awards meeting of the New Jersey Section ASCE typically held the first or second Friday evening in May for recognition of the award.
- E) The award shall be deposited to the awardee's account with the business office of the institution attended by the applicant, or other agency (office) so designated by the awardee and approved by the Section, before the end of the fall semester of the awardee's senior/final baccalaureate year. Withdrawals from such other agency accounts may be made only with concurrence of the Student Chapter Faculty Advisor who shall assure the Section that withdrawals from any accounts established outside the award winner's university account are utilized for educational expenses only.
